## 1369 - Vacant Building Enforcement Ordinance

Effective June 1, 2013, The City of Ashtabula enacted a Vacant Building Registration Ordinance.

Our records indicate the above listed property is vacant and must be registered with the City of Ashtabula.

Section 1369.01 - Purpose - Structures which are left vacant for extended period of time have been shown to breed crime, pose public safety risks, and reduce property values and the economic viability of the community in which they are found. The purpose of this ordinance is to establish a program for identifying & registering vacant residential & commercial buildings; to determine the responsibilities of owners of vacant buildings & structures; and to provide incentives for the rehabilitation & productive use of vacant buildings. Shifting the cost or burden of the existence of vacant residential & commercial structures from the general citizenry to the owners of the buildings is an intended result of this ordinance.

You can view Chapter 1369 of the Ordinance in its entirety and all the guidelines in detail on our website under the housing section or visiting our office.

According to section 1369.99, anyone violating this ordinance will be subject to the penalties listed in section 1361.99, which are as follows:

Any violation or failure to comply with provisions contained in Chapter 13 of the City of Ashtabula Ordinance Code, including failure to comply with notices issued thereunder, will be subject to:

A misdemeanor of the fourth degree. Each day of violation or failure to comply shall constitute a separate offense.

We encourage you to take this matter seriously and have your structure registered as soon as possible to avoid any legal action taken against you.

Enclosed is a registration form that you will need to fill out and return to our office with the proper fees due.

If you have more then one property that is vacant, please list them in the extra spaces we have provided, so that we can update our system accordingly.
